**Preservation and restoration of the Hall has begun. The Hall has been raised by Heritage Movers in preparation for Sand Prairie Construction to pour the basement. The surprise requirement (\$110,500) for architectural plans approved by the state busted a large hole in our budget. To ensure completion, including sewer, water, toilets and a restored front porch, we need to raise an additional \$10,000. Brothers are requested to seek funding and donations to this purpose. For those that haven't heard, Brother Young was elected President of the Boscobel Grand Army of the Republic

Hall Inc. Brother Chroninger is the Vice President, and Loretta Hooker is the Secretary/Treasurer. The Preservationists are the owners of the Hall. Having worked on this project for 15 years, Heritage Movers afforded Brother Young the privilege of operating the lift equipment for the final 14 inches of the lift. I will be forever grateful. It was an awesome experience.
