Commander's Column

Brothers,

Although there are a few items to finish, we are on the verge of completing the Last Soldier Marker program in Wisconsin. The pandemic caused us to curtail large gatherings during 2020, but public dedications were held that year by Camp #8, by Past Department Commander Tom Brown and Camp #1, and by Camp #2, with participation of Sisters of the ASUVCW and of Detached Tent #23 of the DUVCW. Also, during 2020 Past Department Commander Brian McManus conducted fifteen small dedication ceremonies, and I performed another eleven.

During 2021, I conducted well-attended public dedication ceremonies in Dunn and Taylor Counties, and Past Department Commanders McManus and Graf held six small ceremonies. Along with the

County Veterans Service Officers I will be conducting public ceremonies in Rusk and Polk Counties on October 30. One more dedication will be held this year, in Waupaca County. Cemetery regulations do not permit the placement of flag holders in the Central Wisconsin Veterans Memorial Cemetery, the burial place of last veteran Israel J. Cannon (see his biographical sketch in this edition of the *Dispatch*), so we will donate a marker to the Waupaca Historical Society, to be displayed in the historical "King Cottage", a frame residence moved from the Veterans Home to the society's museum grounds. The date for that event is to be determined.

The last two Wisconsin Last Soldier Markers will be dedicated in late March or early April 2022, at the request of marker purchaser John Dudkiewicz of Company B of the 2nd Wisconsin Infantry reenactors.

One other task remains for Wisconsin veterans, and that is to finish the biographies found on the Last Soldier page of the Department web site. Please contact Department Junior Vice Commander and project leader Robert Koenecke if you are willing to help here.

- 1. Brian D. McManus, PDC is appointed Department IRS Compliance Officer to assist the Department Officers in monitoring compliance by the Department and each of the Camps within the Department with respect to the furnishing and filing of Information Returns (IRS Forms 990 and 990-N) and such other documents needed to assure that the Department and Camps retain their status as Tax Exempt Entities, and that contributions are deductible.
- 2. The attention of Department and Camp officers is directed to Chapter V, Article V of the General Regulations of the Order (C&R pp. 120-121), which constitutes the Document Retention Policy of the Order, and which is binding on all Departments and Camps. Adherence to the Document Retention Policy is an IRS requirement, and will be monitored by the Brother appointed in Paragraph 1above.
- 3. Department and Camp officers are encouraged to become familiar with the "Charities & Nonprofits" section of the IRS web site.

1. The attention of Department and Camp officers is directed to the following National Policies pertaining to overall best management practices, which are found under the Governance and Forms section of the National web site, and are binding on all of us:

2. Commander-in-Chief Mike Paquette has called Zoom meetings for Department Commanders on September 25 and 26, and will hold similar meetings on a quarterly basis. Brothers of the Department of Wisconsin are invited to submit questions, suggestions, or concerns they have about National policies or operations to me in advance, so that I can share them with the C-in-C and other Department Commanders.

3. C-in-C Paquette has also instructed Department Commanders to furnish interim reports on Department and Camp activities in advance of the meeting of the Council of Administration held in conjunction with the Gettysburg Remembrance Day activities. Camp Commanders are asked to furnish me with any information concerning Camp activities or initiatives they would like for information of the Council of Administration by October 15, 2021.

4. The Form 3 Membership Application (revision of May 2021) has replaced all other forms for the purpose. Camp Junior Vice Commanders and Recruiting Officers are requested to download the forms from the National web site and to forward them to each Brother of their respective Camps by email attachment, or by hard copy for those who do not communicate by electronic means. The form is fillable, and the Camp JVC should fill in his name and contact information on the last page of the form before distributing it.

5. Camp Junior Vice Commanders and Recruiting Officers should familiarize themselves with their respective Camp dues structures (including any prorations and effective dates) so that this information can be communicated to recruits in timely fashion.

Br. Thomas Ludka has worked at identifying and marking hundreds of Milwaukee area Union veterans' graves for the last 18 years. He was instrumental in setting up a funding mechanism to pay for setting new government headstones in one cemetery and, with a WRC sister, made presentations to community groups, telling the soldiers' stories and publicizing the marking project. The cemetery has nearly 1200 Union soldier burials. Of these, over forty graves were unmarked or markers were in need of replacement. The second cemetery has over 350 Union soldier burials. Each of these has been entered into the National database. He was instrumental in pressuring a local community to take responsibility for an abandoned cemetery with at least one Union soldier buried there...and then helped with the cleanup.

Brother Peter Keepman, Camp memorials officer, researched and photographed a dozen monuments, plaques and historical markers, compiling a 19-page report to the Camp and Department. Keepman found that a 1930s memorial rock to Col. Jerome Watrous of the 6th Wisconsin Infantry had been moved in recent years from a grove of trees in Hales Corners to a new veterans memorial in a city park.

The Camp 1 newsletter also ran photos of all seven historical markers, taken or compiled by Keepman and PCC Tom Mueller. The earliest marker was installed in 1972; the latest 2018. Some of the markers are showing some aging.

Camp 15



Camp #15's honor guard commemorated the 114 Civil War veterans buried in the Burlington Cemetery in Burlington, Wis., with a three-volley musket salute on Sept. 26. The salute was part of a "Whispers from the Past – Honoring Our Heroes" commemoration hosted by the Burlington Cemetery Association.

Leading the Camp #15 honor guard salute was Brother Bob Koenecke, just recently appointed to the Burlington Cemetery's board of directors. Standing at the Civil War monument in the cemetery, Brother Koenecke noted that the names of the 114 Civil War veterans buried in the cemetery, including the nine soldiers who died on the battlefield, are inscribed on the monument.

The monument, made of Sutherland Falls white marble from Virginia, was dedicated in May 1880 when two Civil War soldiers, one who had lost a leg, another an arm, unveiled the monument, Brother Koenecke said.

"It was quite an undertaking to erect this monument," he continued. "It is thought to be the first such memorial in southeastern Wisconsin."

After the commemoration, Camp #15 members handed out brochures promoting the SUVCW and Camp #15 at an information table set up in the cemetery.

Camp 56

Camp 56 met at the White Bear Lake home of Junior Vice Commander Gary Carlberg on August 14, 2021. The Camp's next meeting will be November 13, 2021 at either the Scottish Rite or JVC Carlberg's home. The meeting agenda will include the nomination and voting for new officers.

Camp 56 conducted its first Last Soldier grave dedication on September 4, 2021 at Round Lake Cemetery in Shamrock, Aitkin County, Minnesota. The ceremony honored Pvt. Lendall Sargent of H Company, 12th Maine Volunteer Infantry. Private Sargent enlisted at age 15 in March 1865 and served until April 1866. He spent the later decades of his life in northern Minnesota, working as a logger camp foreman. Private Sargent died in 1938 at the age of 88.

On the same date, September 4, the Camp conducted a Remembrance Ceremony for Private Israel Stephens (1837-1914), Independent Company B, West Virginia Volunteer Infantry Battalion. Private Stephens enlisted in October 1862 and mustered out in April 1864. He served his entire term of service on garrison duty in Wheeling, West Virginia. Private Stephens is an ancestor of Brother Jimmy Johnson of Camp 56. The ceremony was conducted at Private Stephens' grave in Pine Grove Cemetery, Palisade, Minnesota.

Camp 56 is planning its next Last Soldier dedication ceremony for October 9, 2021. To be honored is James A. "Cap" Colehour, who served in Company I of the 92nd Regiment of Illinois Volunteer Infantry. Private Colehour died in 1938 and was the last Union soldier to be buried in Otter Tail County, Minnesota, in Lakewood Cemetery, Battle Lake, Minnesota.

Camp 56 has one remaining date for 2021 for documenting Civil War veteran graves in Lakewood Cemetery, Minneapolis, on October 16.

The committee will make an initial public report at the Elks Lodge in Downtown Madison on December 11, 2021.



Wisconsin Department Commanders By PCinC Steve Michaels with research assistance from PDC Kent Peterson



Jessie Drake presided over the 1921 Wisconsin Department encampment, held in Antigo on June 6th through 9th.

Jessie Theodore Drake was born September 26, 1889, in Antigo, the son of James and Cora Drake, the oldest of three children. James was a rairoad yard conductor.

His grandfather, Samuel, mustered in Company F, 6th Illinois Cavalry on January 9, 1862, for three years.

Jessie graduated from the Antigo High School Class of 1909.

He married Laura A. Elliboat in 1914, on his 25th birthday, in Plainwell, Michigan.

The following year, he started a 39-year career as an engineer and fireman on the Chicago & Northwestern Railroad Company



from Antigo.

After Antigo's Sons Camp, W.H. Blines Camp #7, organized for the third time in May 1910, Jessie Drake signed on.

Drake was elected Dept. Sr. Vice Cmdr. at the 1919 Department Encampment and attended the National Encampment in Columbus, Ohio that year. He was elected Department Commander the following year at the Encampment held in Antigo. He was the first Dept. Commander with a grandfather who had served in the Union forces and one of the youngest to hold the post in recent years.

As the Drakes had no children, they devoted their free time to fraternal societies.

His wife, Laura, was the Auxiliary's Department Patriotic Instructor.

Sadly, the post-World War I depression continued to adversely affect membership in fraternal societies. A membership drive was encouraged in every Camp in the state. The establishment of Auxiliaries was also encouraged. The Commander-in-Chief set Wisconsin's goal at 100% or 1000 new members. Active and interested brothers were commissioned local organizers.

Two Camps were chartered: On August 2nd, Drake installed 16 members of Mary Wood Camp #39 in Ellsworth and presented their charter. On December 2nd, Robert Hughes Camp #19 was organized in La Crosse with 49 members.

On February 19th, Drake presided over the largest class of candidates ever mustered into Madison's Henry Harnden Camp #2. The occasion was a visit by the Sons' Commander-in-Chief, P.A. Barrows, who was also Nebraska's lieutenant governor. Wisconsin governor John J. Blaine provided a welcoming address and Madison Mayor I. Milo Kittleson was among those initiated into the Camp. After the muster service, a patriotic program was held, which included vocal and instrumental music and addresses by Barrows and Drake.

In January 1921, DC Drake suggested the newly created War Medal be presented publicly by Camps to those who served. This would both recognize those recently returned servicemen, attracting more to the Order and call favorable attention to the Sons of Veterans, U.S.A. However, by the 1921 Dept. Encampment, Wisconsin's membership had shrunk to 1,008 members in 31 Camps. On the bright side, the department was back in the black financially.

After his term, PDC Drake served as Dept. Chief of Staff in 1922 and 1923 and as a Camp Organizer in 1927.

As the GAR diminished, so did the SUVCW. Despite surviving the Great Depression, Blines Camp 7 officially disbanded in December 1940.

In 1955, Jessie Drake retired from the railroad and filed for his pension. His retirement was short lived, however.

PDC Jessie T. Drake died November 18, 1958 at the age of 69 and was buried in the Antigo Cemetery. He had also been a member of the Odd Fellows, the Modern Woodmen of America, and the Brotherhood of Locomotive Firemen and Engineers.

Touring the renovated Milwaukee Soldiers Home

The Milwaukee Soldiers Home and Camp 1's longtime meeting site there have gone from a decrepit, creaky, untouched-for-60-years-or-longer facility to a bright, modern place for homeless veterans or those who were at risk for being homeless.

Building 1 and Old Main were transformed along with four smaller buildings in a \$44 million project.

Camp 1 PCC David Howard, Auxiliary President Toni Howard and Chaplain Dean Collins went on tours led by Laura Rinaldi, one of the mainstays of Reclaiming Our Heritage, which ended in 2012. The goal of the event was to help save the buildings.

Camp 1 was booted from Building 1 in 2014 when the VA's hopes and plans for the housing were beginning to be formulated. Construction did not begin until years later, and the work was finished in the last few months.

Rinaldi is taking small groups to Old Main and Building 1.

Collins says the two buildings are now "a spectacular sight; so bright, clean, and well-designed for the veterans who actually live there."

At Building 1, which was the Administration Building of the Soldiers Home, "the downstairs, where the old post office was, has been restored to include all of the old mailboxes; they look brand new!!! But of course they are decorative only. Adjacent (behind) the mailboxes is a long fully equipped kitchen. The whole thing looks so good, I wish I could move in myself."

David Howard took photos every time he was something neat or important, which was often. "The Camp's old meeting room "is rather nice. No chipped plaster, all painted and new a table and chairs with a game table," he said.

He also saluted the new windows. When the Camp was there, if we opened a window, a book had to be used to prop up the sash. And in our last meeting, the heat and water already had been shut off. Toni Howard said: "Building 1 was beautifully restored. Everything was so bright and clean. The meeting room that the Auxiliary ladies met in was redone and set up as a lounge. It had several chairs in there and a table. It was a far cry from when we met in there with the chipping and peeling paint.

"The steps leading up to the second floor were really nice," Toni reported. "They seemed nice and solid with no creaking sounds," and no longer tilt to one side.

As for Old Main, David says: "The floor of the first floor is wood, original to the building. Each of the four floors that we toured had impressive windows to the east in the tower section."

Those distinctive windows always were a main feature of the Old Man, and now are better than ever.

Overall, the project provides 101 supportive housing units. It is detailed at

Old Main has 70 one-bedroom apartments and 10 two-bedroom apartments; 11 are reserved for women only, in a separate, secure area of the building. Plus flexible lounge areas for gathering, a club room with kitchenette, dining area and billiards, a business center with 12 computers to use, a workforce skills training center, two fitness areas, multiple laundry facilities and offices for on-site building management, security and care coordination services.

Building 1 now has 14 single-room occupancy units, five shared restrooms, a shared laundry room, various lounge areas for gathering, a club room with a foosball table and TV lounge, the shared kitchen and shared dining areas.

The Zablocki VA Medical Center will provide case management and supportive services. All residents will have access to on-site help such as peer-to-peer counseling, benefits assistance, education training, employment assistance and sobriety maintenance.
