## MEET THE WISCONSIN DEPARTMENT COMMANDER

### About the Department Commander

**PCC Kent A. Peterson** was elected our Department Commander at the Department Encampment held June 11 at Waukesha. He previously served as Department Senior Vice Commander.

Br. Peterson's interest in the Civil War began when he was researching his family history in the early 1990's and discovered he had an ancestor who fought for the Union. His ancestor, Cpl. Henry Grob of Co. H, 28<sup>th</sup> Wisconsin Inf. Vols., was a Swiss immigrant from Brookfield, Wis.

Br. Peterson joined the SUVCW in 1994 and was assigned to Ammi Hawks Camp #3, ostensibly because his own Civil War ancestor fought alongside Ammi Hawks during the war. In 1999, he received a telephone call from someone he had not seen in more than 25 years – Fred Murphy, one of his former teachers from high school. Brother Fred invited him to attend a Camp 1 meeting and even volunteered to drive him there. Brother Fred's Irish charm proved impossible to turn down, so they went to a meeting. At the time, Camp 3 was preparing to disband, so he transferred into Camp 1.

Soon thereafter, he accepted the position of Camp Patriotic Instructor when asked by his Camp

Commander, Fred Murphy. He also served as Camp Senior Vice Commander before being elected Commander in 2002. Brother Peterson has also been Department Patriotic Instructor and Senior Vice Commander, publishing the *Department Dispatch* newsletter since 2001. At the same time, he developed the Department Web site and continues to maintain it as Dept. Signals Officer, and he has also just completed two years as National Webmaster. He is a member of the Sons of Veterans Reserve.

Brother Peterson is a graduate of Milwaukee Area Technical College with an Associate Degree in Photography, and a graduate of Milwaukee School of Engineering with a Bachelor's Degree in Management Systems. He has been employed at MSOE since 1977, and currently works in the marketing department managing the university Web site.

He is a member of the Milwaukee County Historical Society, Wisconsin Historical Society, and Civil War Preservation Trust, and is a member of the board of directors of the Higher Education Cable Consortium, which operates an educational cable television channel.

Brother Peterson and his wife, Luanne, have been married for 25 years and have a son, Kevin, who is about to enter his junior year at UWM as a music major. As an accomplished trumpet player, Kevin has played "Taps" at several Camp 1 events.

As I complete my term as your Commander-in-Chief and reflect on my visits to other Departments across the country, I am reminded of our Wisconsin Department's positive attributes: its dedication, enthusiasm, and its great potential for the future.

These were brought home to me in a report that the Executive Director recently forwarded to me. It listed our own Wisconsin Department as one of eleven departments, which had submitted its annual report on time. This is no small feat, as the annual report requires the cooperation of Camp and Department Secretaries and Treasurers for it to be compiled and filed in a timely manner.

Additionally, of those eleven Departments (there are 26 in all), our Wisconsin Department was one of only five, which showed a membership increase. Of the five, Wisconsin was fourth in highest percentage increase.

A couple of our brothers brought a new man into our Order over the last year and that's terrific, but I know our Department can do much better. How many of you will follow Br. Gary Young's example? Br. Gary, of L.G. Armstrong Camp 49, recruited three new brothers this past year. For his work, I was pleased to appoint him a National Aide and so, Gary now proudly wears a ribbon of the SUVCW's National colors behind his membership badge.

The Department in first place this year? You may be interested to learn that Kansas had the largest percentage increase (18%). Despite limited resources (only 97 brothers in four Camps), it's determined to grow. How determined? This is the second consecutive year that Kansas will be recognized for significant growth by receiving the U.S. Grant Cup at the National Encampment.

The last time that Wisconsin was awarded the U.S. Grant Cup was in 1963. That year, our Department tied with Indiana and we got to keep the trophy for only six months. The work we do is very important, but it sure would be nice to be recognized as the top Department again, wouldn't it?

We have a great potential for the future...all we have to do is reach for it.

From Tom Brown, Department Patriotic Instructor ---

Battles are decided on battlefields; campaigns are decided by logistics. As the Union Army of the Potomac moved south toward Richmond in the spring and summer of 1864, its soldiers required tons of food, clothing, forage, ammunition, and other equipment to function and survive. An interruption even for a few days could spell disaster.

Union control of the Chesapeake Bay and Virginia's navigable rivers in 1864 gave the Union high command the ability to move vast amounts of supplies by water to rapidly moving soldiers. Huge Union river bases at Belle Plain and Aquia Landing (Potomac), the White House (Pamunkey), and City Point (James) were established as the army moved south. In order to maintain contact with his bases, Grant had to keep his back to the rivers. Consequently, he always moved by the left flank, to the east, when maneuvering around Lee's army. From those depots, miles of wagon trains and railroads delivered supplies to the front lines.

Robert E. Lee's Army of Northern Virginia relied on railroads for supply during the 1864 campaign. Lee fought to protect his rail lifelines at Hanover Junction (the intersection of the Richmond, Fredericksburg and Potomac and the Virginia Central lines) and at Petersburg. But the weight of Union provisions skillfully brought to bear by Federal officers - and the tenuous nature of Confederate supply lines proved decisive.

**From Department Graves Registration Officer Virgil Matz ---**

The lists below show grave registrations for each county and also the number of Civil War Veterans living in each county in 1885. This shows that the number of living in 1885 plus the number that died before 1885 leaves many graves that need to be registered. Dane Co. shows a county that has been done with the exception of one cemetery.

I became GRO for Col. Henry Harnden Camp #2 in 1996. At this year's Encampment I was honored to be made Department GRO.

The goal of SUVCW National Grave Registration Project is to locate the final resting place of all Union Civil War Veterans and entering them in the National Grave Registration Database, <http://www.suvcwdb.org/home> The 1885 Wisconsin Soldiers Census states that there were almost 30,000 Civil War Veterans living in Wisconsin. Many had died before the census and are buried in Wisconsin. So far there have been 10,383 burial registrations. This is great, but it shows that a lot more work needs to be done. To meet the goal it takes many volunteers. I have done over 3,000 and I know Brother Don Strube from Old Abe Camp #8 has done many more than that.

I plan to correspond with all Camps offering suggestions on how to document, hints and help if they need it. I will also try to make some of their meetings.
