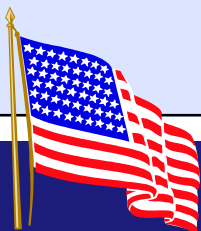

REPORT ON THE 2003 CENTRAL REGION CONFERENCE

The 2003 Central Region Conference was hosted by the Department of Michigan and convened on October 4th in Grand Rapids. The conference went very well this year. Several hundred people, including local officials and school children attended the rededication ceremonies for the restored Civil War monument in downtown Grand Rapids on Saturday morning. This was the culmination of nearly three years of fundraising to raise the \$250,000 needed for the four months of restoration work required. The ceremony followed closely the original 1885 dedication ceremony. The Department's two REAL Sons arrived in a horse-drawn carriage and one flipped the switch at the end of the ceremony, activating the fountain portion of the monument. The restored monument is seen at right.

After lunch, National Counselor PDC James Pahl spoke on Robert's Rules of Order and answered questions about proper meeting procedure. During the business meeting, the new Past CR Commander's badge was awarded to those eligible and still living: This included five from Wisconsin: PDC Thomas L.W. Johnson, PDC Ron Aronis, NP Danielle Michaels, PDP Peggy Schaefer, and PDP Rhoda Lemanski.

The banquet that evening paid tribute to the new National Commander-in-Chief, Kent Armstrong. We were also entertained by a brother who provided a dramatic extemporaneous recitation of excerpts from various Civil War-era poems.

Happy 122nd Birthday, S.U.V.C.W.!

On November 12th 1881 Davis Camp #1, Sons of Veterans of Pennsylvania was formed at Pittsburgh, Pennsylvania by Brevet Major August Plummer Davis. Eleven sons of Union veterans were present at the meeting.

A CONFEDERATE IN WAUPACA COUNTY

Editors note: This article is from the Old Abe Camp 8 newsletter of 3 Sept. 2003. It is a compilation of two notes received from Brother Vince Barker.

All, May 14th

I wanted to share with you a great story that was just uncovered here in Waupaca County. To make a long story very short, we have located a Confederate veteran buried at Crystal Lake Cemetery, Town of Dayton, in Waupaca County (I owe Jim Waid bigtime for tipping me off about this and doing alot of the leg work).

What is fascinating is that this veteran was not from a southern state and later moved here, he was a resident of Wisconsin! His name was William "Rebel Bill" Barrington, and he served with Co. C, 18th Mississippi Infantry.

He was wounded and captured at Gettysburg. Not sure of the details of his release or discharge yet (records are on the way) but the family story goes that he walked much of the way back to Wisconsin, back to Oconto County, where his brother Richard met him at the door with a rifle. Richard had served with Co. F, 12th Wisconsin Infantry. William eventually moved to the Town of Springwater in Waushara County and was known to family and friends as "Rebel Bill". Most of the Barrington family also moved from Oconto to Waupaca or Waushara Counties.

So how did William end up in Mississippi prior to the war starting? Apparently he had gone there to trade horses and when the war

G.A.R. FLAG AND POST BANNERS

Within the last few weeks there has been a small discovery in the Waupaca area pertaining to the G.A.R. Waupaca Post #21 flag and the G.A.R. Stevens Point Post 156 Banner. It seems that for the last 42 years or so the Waupaca Post flag has been stored in a closet at the Waupaca Historical Society. It was recently unfurled for the first time in decades to be seen by members of the King Civil War Round Table. Several members of the Round Table are also members of Camp #8. So it was of special interest to many that laid their eyes upon this historic flag. This flag was supposedly used at the Grand Army Home in King as well as in Waupaca. Many Camp or Round Table members had family belonging to that Post.

Also, the Stevens Point Post 156 banner turned up after many years of not so careful storage. The banner is made of silk with a cloth backing. The silk is in a

shredded condition. The writing on the silk had held together due to its painted structure. There is enough of the banner left to see what Post it was from. The flag is attached to the original top part of the flagstaff. This banner was thought to be long gone. A photo seen with this article shows the frailness of the banner.

There is still a chance that there are more of these precious items from our past to be found. We can only hope that by honoring our Boys in Blue and promoting their heritage that the public will speak up and alert us to the symbols of our past. Many of the flags and banners have been put in museums never to be seen again. Please be aware that if found these items should be handled with the utmost care. Most were made with silk, which under most conditions does not weather well. I would be pleased to learn of any other G.A.R. flags or banners in the area so that they could be documented, photographed, and stored in a safe manner.

DID YOU KNOW ...

The Sons of Union Veterans of the Civil War awards two \$1,000 scholarships annually for tuition and books to high school seniors and college students (male or female) contingent upon their enrollment at an accredited four year college or university prior to December 31st of the year the scholarship is granted. The applicant should be a descendant of a Union Civil War veteran who was honorably discharged or who died while in service; rank in the upper one-fourth of high school graduating class, have a record of performance in activities both in school and in the community; among other qualifications.

If selected for a scholarship, the check will be sent, upon proof of the recipient's acceptance to a college, directly to the college of the student's choice made out to the student and the college. We are ordering a Confederate marker for William's grave (Richard already has a military marker) and are in contact with several of his descendants. At some point we hope to hold a joint marker dedication, for William and Richard similar to the one held in Crandon last year. I will keep you all posted on the plans for that

On Saturday morning (August 23rd) we installed the marker for Rebel Bill Barrington at Crystal Lake Cemetery. My good friend from the 10th Tennessee, COL(R) Dan McGraw came to help out. What made the day special though was Rebel Bill's grandson, Walter Batten, 84, of New London came also. What a nice man. He was 6 years old when Rebel Bill died so he remembered him pretty well. He said "grandpa" was almost totally blind by that time but he would still play and wrestle with the grandkids in the yard. He said he remembers pulling grandpa's whiskers.

Later that day I had a phone message from Linda Thompson who is Walter's daughter. She said her dad really enjoyed being there and getting to see the marker put in. That's what it's all about. It makes man handling that darn 240 lb. marker all worth it. - *Vince Barker*
